Changes since Incoterms 2000 & 2010

- 11 clauses instead of 13, DAT and DAP replacing clauses DEQ, DAF, DES and DDU.
- The former DAT has been changed to Delivered at Place Unloaded (DPU) to emphasise that the place of destination can be any place and not just a "terminal".
- For clauses FOB, CFR and CIF, goods are regarded as having been delivered as soon as they are on board the ship, and not as previously, at the reeling of the ship.
